3. Mayor's or Business Permit (valid and current) or official receipt of renewal and attached with the old permit
4. Tax Clearance per E.O. No. 398, s.2005, as finally reviewed and approved by the BIR

Technical Documents:

1. Audited Financial Statements, stamped "received" by the Bureau of Internal Revenue (BIR) or its accredited and authorized institutions, for the preceding

calendar year, which should not be later than two (2) years from bid submission;

2. Statement of all its ongoing and completed government and private contracts within the period stated in the Bid Data Sheet (BDS)
3. Statement of the bidder's Single Largest Completed Contract (SLCC)- (similar to the project to be bid) amount of which is at least 50% of the ABC;
4. PCAB License
5. Original copy of Bid Security if in the form of Bid Surety or original copy of Notarized Bid Securing Declaration
5. Project requirements:
 - a. Organizational Chart for the contract to be bid;
 - b. List of contractor's personnel (e.g. *Project Manager, Project Engineers, Materials Engineers and Foreman*), to be assigned to the contract to be bid, with their complete qualification and experience data;
 - c. List of contractor's major equipment units, which are owned, leased, and/or under purchase agreements, supported by proof of ownership or lessor/vendor for the duration of the project, as the case may be; and

Omnibus Sworn Statements and if applicable Original Notarized Secretary's Certificate in case of a corporation, partnership, or cooperative or Original Special Power of Attorney of all members of the joint venture giving full power and authority to its officer to sign the OSS and do acts to represent the bidder
