The CAMARINES NORTE STATE COLLEGE, through the 2022 QUEEN PINEAPPLE FUND intends to apply the total amount of Four Million Four Hundred Sixty-Nine Thousand Two Hundred Thirty-Four Pesos and 67/100 (P4,469,234.67) being the Approved Budget for the Contract (ABC) to payments under the contract for the Facilities of the Queen Pineapple Research and Development Center in CNSC-CANR Campus, Labo, Camarines Norte with Reference Number: <u>CNSCIMPQP2022</u>.

- The CAMARINES NORTE STATE COLLEGE now invites bids for the above Procurement Project. Completion of the Works is required ONE HUNDRED NINETY (190) CALENDAR DAYS for Approved Budget for the Contract in the amount Four Million Four Hundred Sixty-Nine Thousand Two Hundred Thirty-Four Pesos and 67/100 (P4,469,234.67). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 3. Interested bidders may obtain further information from the Head, BAC Secretariat, Records Office, 2<sup>nd</sup> Floor, General Administration Building and inspect the Bidding Documents at the address below from 8:00 A.M. to 5:00 P.M. Monday to Friday
- 4. A complete set of Bidding Documents may be acquired by interested bidders on October 12-28,2022 from given address upon payment of non-refundable fee pursuant to the latest Guidelines issued by the GPPB in the amount of five thousand pesos (P5,000.00). CNSC shall allow the bidder to present its proof of payment for the fees by presenting the original copy of the official receipt or through electronic mail.
- 5. The **CAMARINES NORTE STATE COLLEGE** will hold a Pre-Bid Conference <u>October</u> <u>19, 2022</u> at the **College Library at exactly 2:00 o'clock in the afternoon** which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat through manual submission on <u>November 2, 2022 on or before 1:00 o'clock in the afternoon</u> at the 2nd Floor, Records Office, General Administration Building, Main Campus, Daet, Camarines Norte. Late bids shall not be accepted.
- 7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 8. Bid opening shall be on November 2,2022 \_at exactly 1:45 in the afternoon at the second floor <u>College Library Building.</u> Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
