- The Camarines Norte State College now invites bids for the above Procurement Project. Delivery of the Goods as specified in Section VI (Schedule of Requirements) of the Bidding Documents. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from Camarines Note State College and inspect the Bidding Documents at the address given below during office hours, Monday to Friday.
- A complete set of Bidding Documents may be acquired by interested Bidders on December 22, 2022- January 10, 2023 in payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPBB. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- The Camarines Norte State College will hold a Pre-Bid Conference on December 29, 2022 at 1:30 in the afternoon at the 2nd Floor, Library Building, Camarines Norte State College Main Campus, Daet, Camarines Norte which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before January 10, 2023 at 1:30 in the afternoon. Late bids shall not be accepted.
